



DIY Walk of Hope & DIY Fundraiser Application & Agreement

Thank you for your interest in hosting a **DIY Walk of Hope or DIY Fundraiser** in your community. RESOLVE: The National Infertility Association is a 501(c)(3) non-profit organization. Funds raised by you and your community will help millions of women and men struggling to build their family by growing RESOLVE's local support groups, educational programs, public awareness activities and advocacy efforts.

Once you submit your application, you will receive a confirmation email letting you know your registration has been received. You will also receive instructions on how to use your individual or team **DIY Walk of Hope or DIY Fundraiser** fundraising page. In addition, a toolbox of helpful RESOLVE resources will be available for your use.

This Agreement sets forth the terms and conditions for the **DIY Walk of Hope or DIY Fundraiser**.

- You are not permitted to use the RESOLVE corporate logo (the swirl as it appears on this letterhead). You are encouraged to use the DIY Walk of Hope logo or the RESOLVE Fundraiser badge, which will be provided to you. The use of the logo to design **DIY Walk of Hope or DIY Fundraiser** promotional materials not provided by RESOLVE must be approved by RESOLVE staff before use of logo (i.e., t-shirts, local signage, promotional materials.)
- *DIY Walk of Hope* must be named and branded by city or location (i.e., Nashville, TN *DIY Walk of Hope*.)
- RESOLVE is **NOT** responsible for any expenses associated with your **DIY Walk of Hope or DIY Fundraiser**.
- All funds raised through the **DIY Walk of Hope or DIY Fundraiser** go directly to RESOLVE.
- **DIY Walk of Hope and DIY Fundraiser** volunteers may solicit in-kind donations and sponsorships from local businesses to support the **DIY Walk of Hope or DIY Fundraiser**. Sponsors either pay the expense directly or pay RESOLVE and RESOLVE pays the expenses. Volunteers may not accept cash or checks made out to an individual. Individuals may pay expenses directly and be reimbursed by RESOLVE from the money paid by event sponsors. Receipts are required.
- RESOLVE will supply policies and guidelines which may be updated from time to time. All volunteers will comply with these documents.
- RESOLVE will not assume any liability associated with hosting a **DIY Walk of Hope or DIY Fundraiser** including but not limited to personal injury, property damage, loss or theft.

- RESOLVE **DIY Walk of Hope and DIY Fundraiser** volunteers must comply with all local, state and federal laws and regulations when planning and implementing a RESOLVE **DIY Walk of Hope or DIY Fundraiser**.
- Should the venue you select for the **DIY Walk of Hope or DIY Fundraiser** require a Certificate of Insurance, RESOLVE will **NOT** be able to provide one. RESOLVE can help facilitate obtaining coverage and a Certificate of Insurance by putting you in touch with an insurance agent.
- RESOLVE reserves the right to terminate this agreement at any time.
- RESOLVE requires that any effort to raise funds for RESOLVE does not utilize the services of telemarketing or selling tickets or products over the phone. Also, no organization or individual can derive a commission, bonus, or percentage-basis compensation for helping to raise funds for this event.
